REALTORS® Code of Ethics Training

Effective January 1, 2001 through December 31, 2004, and for successive four (4) year periods, REALTORS® are required to complete a 2 ½ hour course on ethics. All NOCBOR members (excluding Affiliate members) must complete the required training no later than December 31, 2012. Pursuant to the mandate of the National Association of REALTORS®, failure to complete the required periodic ethics training shall be considered a violation of a membership duty. Additionally, failure to meet the requirement will result in suspension of membership for the first two months (January & February), of 2013, or until the requirement is met whichever occurs sooner. On March 1, 2013, members who have not completed the Code of Ethics training shall be automatically terminated.

NOCBOR will provide free offerings throughout 2012 for the necessary ethics training program, featuring Jack Waller, President of NCI Associates. The 2 ½ required hours will be personally presented by Jack, in a style that will hold your attention, as well as enlighten you with the amendments recently passed by the Directors of the North Oakland County Board of REALTORS®.

Legal Q & A

Q: I represent someone who is interested in leasing a house. Am I required to provide an agency disclosure form?

A: YES. The agency disclosure law (MCL 33.2517) defines a real estate transaction as one involving the sale or lease of real estate consisting of not less than one or not more than four residential dwelling units or a building site for a residential unit.

Q: For estate planning purposes, my neighbor would like to add her 14 year old daughter to the deed to her home. Is this legal?

A: YES. There is nothing prohibiting a minor from holding title to real property. The difficulty will arise if the neighbor and her daughter later want to sell the home while the child is still a minor. Your neighbor should consult an estate planning attorney prior to adding her daughter to the deed.

Q: I often keep track of the expiration of other companies' listings so that I can call the seller immediately and hopefully persuade the seller to list with me. Is this permissible?

A: YES, however, before calling such a seller, you need to make certain that the seller is not listed on the Federal Do-Not-Call Registry. Also, firms with agents who use this practice need to maintain a company specific do-not-call registry.

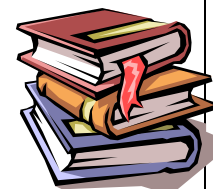
